Directly beneath and separate from the CUI designation indicator box, is the distribution statement in its entirety. Additional markings are included as required, e. Scientific or technical information resulting from contracted fundamental research efforts will normally be assigned Distribution Statement A, except for. Unless specifically exempted in the contract, DoD and Vendor shipping activities must apply address markings using a bar coded MSL. Multiple suppliers can provide necessary software. An internet search will display multiple options. The Code 39 (Linear) and 2D (PDF417) bar codes must be easily.
