

Requirements for reinforcing openings of distribution boxes

Overview

14 requires at least 6 inches of free conductor at every box, measured from where the wire emerges from the cable sheath or raceway. These sections apply to installations, both temporary and permanent, used on the jobsite; but these sections do not apply. The National Electrical Code (NEC), published as NFPA 70, sets minimum safety standards for electrical junction boxes in residential and commercial buildings. The employer shall ensure that employees use a ladder or other climbing device to enter and exit a manhole or subsurface vault exceeding 1.
