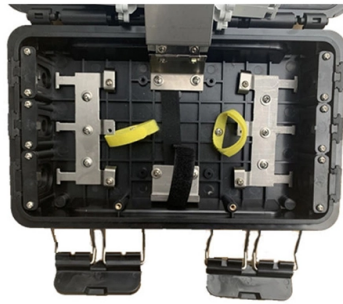


Standard Height for Communication Optical Cables Crossing Roads



Article Overview

The standard minimum vertical clearance for communication optical cables crossing public roads is generally 15.5 to 18 feet (4.7 to 5.5 meters), depending on traffic type and local regulations.

General Guidelines

For public streets, highways, and areas with vehicular traffic, communication cables must maintain a minimum clearance of 15.5 to 16 feet (4.7-4.9 meters) above the road surface to safely accommodate vehicles such as delivery trucks, moving vans, and recreational vehicles . In some jurisdictions or high-traffic areas, this clearance may be increased to 18 feet (5.5 meters) to ensure safe passage for larger vehicles, including fire trucks and specialized construction equipment .

Residential and Private Driveways

For residential driveways or private roads, the minimum clearance is typically lower:

- Residential driveways: Minimum 12-14 feet (3.7-4.3 meters), sufficient for standard passenger vehicles and small trucks .
- Pedestrian-only areas or backyards: Minimum 9.5-10 feet (2.9-3 meters), allowing safe passage for individuals carrying objects overhead . These measurements are taken at the lowest point of the cable's sag, usually mid-span between poles, not at the attachment point
